

2010 Department of Labor Video Competition Copyright Assignment & Release

I, _____, enter into this copyright assignment and release agreement (Agreement) with the U.S. Department of Labor (DOL) for the purpose of participating in DOL's 2010 Video Competition (Competition). I represent and warrant that the Video will not infringe any copyrights or other rights of others, and will contain nothing defamatory or obscene. In addition, I represent and warrant that no portion of the Video is subject to any prior agreement/s that would limit the scope of rights I am assigning here to DOL. I understand and agree that if I make any misrepresentation/s with respect to the rights associated with the Video and assigned to DOL under this agreement, , and if DOL suffers damages as a result of my misrepresentation/s, I hereby agree to indemnify DOL for all damages allowable under the law.

I hereby waive all rights and release U.S. Department of Labor (including its officials, employees, representatives, agents, licensees, successors, and assigns) from, and shall neither sue nor bring any proceeding against any such parties for, any claim or cause of action, whether now known or unknown, for defamation, invasion of right to privacy, publicity or personality or any similar matter, or based upon or relating to the use and exploitation of the Video. Additionally, I waive any right to inspect or approve the finished product or the advertising or other copy of the designated material. I also understand and agree that I will not be compensated for any uses DOL makes of the Video.
